CASA: Helping Local Children in Their Time of Need

This month's speaker will be Sharon Flynn, Outreach/Recruitment Manager For PARACHUTE CASA Butler County. CASA stands for Court Appointed Special Advocates. CASA volunteers are trained to navigate the juvenile court systems to speak up for abused, neglected and abandoned children. Their goal is to find safe, permanent homes for them as soon as possible.

Sharon will talk about how CASA helps children in need, from babies to teenagers.

Sharon studied Consumer Affairs & Communication at The Ohio State University. She was an account manager for Abbott Laboratories in Columbus and resource support specialist for Prestige Technical Services. 

Horse – Geraldine Brooks



Cincinnati Music Hall has stood at 1241 Elm Street since 1878. If it could sing, what music would we hear? If it could talk, what stories would it tell? We hope to hear some of its stories and see behind the curtain during our tour of this iconic Cincinnati Landmark.

Our tour will begin on Saturday, April 20, at 2:30 and will last approximately 75 minutes. Enter at the south end door of the building at the door marked "SCO Box Office." Check-in begins 15 minutes before the tour. Please feel free to bring guests. Music Hall is ADA accessible.

Letter from Our Leader

March is Women's History Month, making it a good time to celebrate women's achievements. At the same time, it's good to remember that our work is not done. We must continue to advocate for women's rights.

One step in the struggle to gain protection for those rights was the Equal Rights Amendment, which was passed by Congress 50 years ago but did not receive the necessary ratification by three-fourths of the states by the March 22, 1979 deadline. Since then, Virginia became the 38th state to ratify the ERA. Then in January 2023, Congresswoman Ayanna Pressley and U.S. Senator Ben Cardin introduced a bicameral, joint resolution to remove the arbitrary deadline for ratification and recognize the amendment as a valid part of the Constitution. However, a year later, this has not been passed. If you wish to add your voice to those wanting to see the amendment adopted, go to www.sign4era.org and sign their petition.

This is also the time of year when we nominate members to make up a slate of officers for the 2024 – 2025 program year. If you would like to become more involved in the branch and hold a position on the board, please let us know. This is an excellent way to get to know the other members and to have a greater impact on the work of this branch.

This month our program takes a look at CASA volunteers who serve as advocates for child victims in the court system, trying to provide equity for those least able to defend themselves. We hope you will join us at 7 pm on March 11 in the Kettering Health Center Community Room.

Did You Know...? The History of Women's History Month

Women's History Month began as a local celebration in Santa Rosa, California. The Education Task Force of the Sonoma County Commission on the Status of Women planned and executed a "Women's History Week" celebration in 1978. The organizers selected the week of March 8 to correspond with International Women's Day. The movement spread across the country as other communities initiated their own Women's History Week celebrations the following year.

In 1980, a consortium of women's groups and historians – led by the National Women's History Project (now the National Women's History Alliance) – successfully lobbied for national recognition. In February 1980, President Jimmy Carter issued the first Presidential Proclamation declaring the Week of March 8, 1980 as National Women's History Week.

Carter's proclamation included this passage:

"From the first settlers who came to our shores, from the first American Indian families who befriended them, men and women have worked together to build this nation. Too often the women were unsung and sometimes their contributions were unnoticed. But the achievements, leadership, courage, strength and love of the women who built America was as vital as that of the men whose names we know so well."
